

## Notice of Proposed Property Tax Levy for the Northwest Home Equity Assurance Program

A public hearing to approve a proposed property tax levy for the Northwest Home Equity Assurance Program will be held on Thursday, October 21, 2021, at 6:30 pm at the Northwest Home Equity Assurance Program located at 3234 N. Central Ave. Ofc. 2 Chicago, IL 60634. Consistent with Executive Orders issued by Governor Pritzker in connection with Coronavirus 19, a novel severe acute respiratory illness that can spread among people through respiratory transmission, Northwest Home Equity Assurance Program will conduct the public hearing to approve the proposed property tax levy via hybrid format.

All hearings shall be open to the public. The corporate authority of the taxing district shall explain the reasons for the proposed increase and shall permit persons desiring to be heard an opportunity to present testimony within reasonable time limits as it determines.
